### PROJECT DESCRIPTION

Working inside the social context and having the aim of making better the life expereinces of the users that are looking for help means that thosethings like the behavioral basic practices have to be known in order to make the actions that operators undertake in the planning and implementation phases of the interventions more lienar, coherent and accountable. The appeal to the socalled "best practices" in the contexts where individuals and organizations operate in hostile and competitive environments has a decidedly profound (Scott, 1998), but structuring them in anorganic, simple and effective way is actually complex; given the limits of their absolute infallibility, in fact, it is better to fix the aim, to be more realistic and not excessivelyambitious, of good practices. therefore speak But why are " good practices" important? Simply because where the immediate and effective action is an absolute

( as in the contexts intervention in and for society), theory has the fundamental role of informing action (Bretschneider, 2004), giving it a solid structure and providing it a launch pad to make it well focused and infallible. Therefore, keep in mind that scientific researches in the psychological and sociological fields are, in this regard, a valid tool that helps to look for and select the theoretical foundations which areuseful for giving life to the criteria that can define a " good practice". A final consideration should be given to the fluidity of "good practices": thesestrictly depend on the context in which social users take part and, particularly operators within the European Union, we know well how the situations in the various territories are very different from each other. In conclusion, one can simply ascertain that open minds and feet on the ground will undoubtedly be our aces up our sleeve!

HAVING SAID THAT, FOLLOWING THE NUMEROUS REFLECTIONS AND STUDIES CARRIED OUT IN RECENT DECADES IN THE CONTEXT OF "GOOD PRACTICES", HERE WE CAN LIST WHAT CAN BE CONSIDERED THE CRITERIA THAT UNDERLIE THOSE:

**OBJECTIVE AND EFFECTIVENESS ORIENTATION:** a "good practice" must necessarily have a strong cause-effect relationship based on the principle that following a planned action corresponds to an expected reaction;

**REPLICABILITY AND ADAPTABILITY:** it can be defined a "good practice" if the act is replicable in the different situations in which is tried to achieve similar objectives;

**FLEXIBILITY AND INNOVATION:** research is constantly updated and "good practices" must be up to date with the theoretical foundations on which they are based:

**RESPECT FOR THE OTHER:** a "good practice" addresses the specific needs of men and women and is able to motivate greater involvement in participation in social inclusion. A "good practice" reflects the foundations of the universal principles of human rights laws;

**EMPOWERMENT:** "good practice" aims at personal growth, aimed at avoiding a possible relapse of the person in situations of marginality and chronic poverty. To do this, a "good practice" must therefore lead the person to overcome the moment of difficulty and understand the importance of updating and training even after the support intervention;

**COHORT WORK:** a "good practice" increases collaboration between professionals, institutions and citizens, including beneficiaries. A "good practice" also aims to promote a significant participation of disadvantaged people, who must actively intervene in decisions and actions.





### RECOVERY CAN TAKE UP TO THREE YEARS

#### THOMAS VONDRAK - VONDICONSULTING, AUSTRIA



The model simulation predicts reduction of Austrian GDP by 4% in 2020,a lmost five percentage points below thepr ojected benchmark scenario without thes hutdown measures. This is a yearlyav erage effect, which is reached after aninitial interannual GDP contraction of almosts even percentage points below thebenchmar k scenario that can be attributed to immedia te post-crisis dynamics, andthat is later reduced due to a partialrecovery before the end of 2020. After the 2020 shock and until 2022, the economywill recover. Howev er, by the end of 2022,

the level of GDP is still likely to be lowertha n it would have been without the COV ID-19 crisis. ### IT IS NECESSARY TO ENHANCE THE NETWORKS

The pandemic has faced us with a challenge that has concerned our own ability - as social workers - to adapt to new ways. The total lockdown and closure of many services have accelerated the processof spreading digital amplifying the difficulties systems, disadvantaged people. We found ourselves living daily in a world made up of platforms and video conferences but to support our users remotely - in search of basic help such as food - the simplest thing was to use the telephone! In fact, many do not have an internet connection or they had the only PC in the house engaged for their children in Distance learning. We have noticed the lack of awareness

of the potential of the smartphone - which many have but do not know how to use. It was difficult and at times very frustrating but it helped us to understand where to orient our design and to concretely understand the importance of a collaborative network! The pandemic has shown us that we are all vulnerable. precarious and dependent, and for that reasons we musthelp each other and do our work with passion! GOL project taught us that it is possible to work in a network, and indeed, it is necessary to enhance the networks, both local and European, in order to face the problems, emergencies and living normality better.
